Comparison of Performance of NDA & UPA-2

Pakistan-Fomented Terrorism

PM Modi's biggest victory is in driving out the scourge of Pakistan-fomented terrorism from most of India. These terrorist attacks have reduced substantially, in general, in all of India and almost all of the attack are concentrated in J&K & north Punjab districts (Pathankot & Gurudaspur) that border J&K.


The attacks in Rest of India (i.e. excluding J&K and bordering districts of Punjab) have reduced from 33 (over 10 years of UPA) to just 2 (over 5 years of NDA). The bombings in public places throughout the large Indian cities was very common during UPA rule, but, as soon as Modi government came into power, such random attacks have been almost totally eliminated in most of the country, except for J&K and 2 districts in Punjab. This has resulted in a large reduction in murder of innocents. The number of victims killed have come down from 866 (in 10 years of UPA) to 1 (in 5 years of NDA)!

As you can see, during UPA rule, there were 33 attacks in Rest of India (i.e. excluding J&K and Punjab districts bordering J&K), with a death-toll of 866 people.

On the other hand, under NDA rule, there have been only two relatively minor attacks in Indian heartland. This was a bomb attack in MP (Bhopal-Ujjain Passenger Train bombing), in which 10 people were injured, but, no one was killed and early in the tenure of NDA, there was an attack in Bengaluru in December 2014, in which 1 person was killed.

This clearly proves that under NDA rule, the intelligence and police force are working much more efficiently. Almost all of the attacks are initiated by Pakistan-based organization, but, they always need local help to complete their mission. Pakistan-based forces clearly haven't stopped targeting India, but, they have been thwarted time and again. And I believe this precipitous decline in attacks in heartland India proves that the government has been able to thwart these attacks because they have been able to neutralize the traitors in our own cities. No local help, no attacks. A full list of incidents is displayed on the last page.

Some of you may say that what about Jammu & Kashmir? Hasn't the situation worsened there? Clearly, the media makes it sound that there is an increased quantum of attacks and deaths in Kashmir. But, data does not point to that. Let's looks at fatalities in J&K due to separatism/terrorism:



As you can see, more violence occurred during UPA rule vis-à-vis NDA. Even when comparing UPA-2, NDA has only slightly higher level of casualties than UPA-2. See a graph comparing UPA-2 & NDA.
